Meagher representing Alexander's; Mr. Chris Vail representing Sycamore Development; and Harwell M. Darby, Jr. Counsel to the Authority.

Mr. Naff called the meeting to order at 8:00 a.m. and declared that a quorum was present.

On motion by Mr. Hale, and seconded by Ms. Wyatt-Jones, the Authority unanimously approved the minutes of the June 21, 2023, regular meeting.

Ms. Meagher, representing Alexander's, outlined a façade grant request for property located at 105 S. Jefferson Street (TM # 1011124), and on motion by Mr. Poe, and seconded by Mr. Baldridge, the Authority voted unanimously to approve a Façade Grant in the amount of \$16,146.21, being the lesser of (1) one-third of the costs of improving the building, or (2) the maximum grant amount of \$25,000 with the construction to be completed on or before May 31, 2024, and the grant funded on or before July 31, 2024, with the requirement that the Economic Development Specialist review the documentation supporting each expenditure to ensure compliance with the Façade Grant guidelines and report back the final amount to the Board as soon as the project is completed, and if not, the applicant will have no further right to draw down the Façade Grant and the allocated funds will be returned to the Authority's general funds.

Mr. Vail, representing 21 Church Ave LLC, outlined a façade grant request for property located at 21 Church Avenue, S.W. (TM # 1011811), and on motion by Mr. Baldridge, and seconded by Mr. Hale, the Authority voted unanimously to approve a Façade Grant in the amount of \$25,000, being the lesser of (1) one-third of the costs of improving the building, or (2) the maximum grant amount of \$25,000 with the construction to be completed on or before December 1, 2023, and the grant funded on or before February 1, 2024, with the requirement that the Economic Development Specialist review the documentation supporting each expenditure to ensure compliance with the Façade Grant guidelines and report back the final amount to the Board as soon as the project is completed, and if not,

the applicant will have no further right to draw down the Façade Grant and the allocated funds will be returned to the Authority's general funds.

Mr. Naff opened the meeting for citizen comment. No member of the public requested to be heard.

Mr. Poe presented the financial report. Mr. Naff reported on the Authority's investment guidelines. On motion by Mr. Baldridge, and seconded by Mr. Hale, the Authority unanimously received the financial report dated as of July 19, 2023, a copy of which is attached to and filed with these minutes as Attachment 1 (3 pages).

Ms. Cundiff presented the Façade Grant Report. On motion by Mr. Hale, and seconded by Mr. Poe, the Authority unanimously approved the Façade Grant Report, a copy of which is attached to and filed with these minutes as Attachment 2.

On motion by Mr. Poe, and seconded by Mr. Hale, the Authority voted to dissolve the Freedom First Revolving Loan Fund and to return the monies back to the Authority's general funds.

Mr. Naff led a discussion on an affordable housing fund. On motion by Mr. Poe, and seconded by Mr. Baldridge, the Authority articulated its support for the City's affirmative housing effort indicating that the Authority would be interested in a specific request from the City for participation in a loan fund with set parameters.

The next Authority meeting will be held at 117 Church Avenue, S.W., Roanoke, Virginia, Wednesday, August 16, 2023, at 8:00 a.m.

There being no further business, the meeting adjourned at 8:41 a.m.
